Welcome to the registration process for the Bike One programme.

During registration you will be asked to provide some personal details and a mobile phone number which will be confirmed by a code sent to you via sms.

During registration you can provide a bank account number or a credit card number in order for your deposit to be returned to you.

BikeOne - Terms and Conditions (effective from 2009-04-01)

Definitions:

1. Terms and conditions - the following regulations describe the terms and conditions of using the BikeOne programme, the laws which govern its use and the responsibilities of the owner and leasee. Acceptance of the aforementioned regulations is a mandatory requirement of any user of the Self-service BikeOne City Rental programme. On acceptance of the terms and conditions the contract between the leasee and the BikeOne Operator comes into effect. By registering with the BikeOne programme you hereby agree to accept the terms and conditions.
2. The contract - the contract between the leasee and the BikeOne Operator, which sets out the mutual responsibilities of the aforementioned parties are described in the terms and conditions. It is agreed that the contract will come into force upon acceptance of the terms and conditions, which is a mandatory requirement of the online registration process.
3. BikeOne programme -the BikeOne programme is the operating name of the Self-service BikeOne City Rental programme who own, undertake and administer all actions related to leasing bikes via www.bikeone.pl
4. BikeOne Operator - The BikeOne Operators are a group of business entities who service and maintain the BikeOne programme
5. The owner of the BikeOne programme is Sanmargar Team Ltd. Ul. Brukselska 17a 03-973 Warszawa KRS 000024506
6. The BikeOne Operator is BikeOne Ltd. ul. Kamieńskiego 51, 30-644 Kraków
7. Self-service BikeOne City Rental - the technical infrastructure, software and equipment which enables rental of a bike from a Rental Point.
8. Leasee - a participant in BikeOne programme who enters into agreement with the BikeOne programme upon acceptance of the aforementioned terms and condition.
